Job Purpose and Direction:

This position will be under the leadership of the Director of MDT. As the Therapeutic Lead, you'll offer psychoanalytic support and assessment to children and young people with emotional or behavioural difficulties, including:

Depression, anxiety, development delay, phobias, aggression, gender dysphoria, consequences of child abuse, self-harming, learning difficulties and disabilities, eating disorders, behavioural concerns, psychosomatic disorders.

You'll need substantial experience of working with children and adolescents in a social care, health or education setting to work as a child psychotherapist.

You'll use a multidisciplinary approach to work within the context of the child's life, for example with their family, or our resident care provision and schools. Your relationship with the child is central to assessment and support.

You will have a working knowledge of 'Trauma and attachment theories' with the ability to draw on your knowledge and understanding to support the practice of our teams and yourself.

You will typically work with children individually, but at times this may also include working with children in a group with other children, or with parents or other family members. You may also be required to see parents or carers without the child being present.

Child and adolescent psychotherapy is a core profession within the portfolio of servicers that AWW offers.

Duties & Responsibilities

Reporting to the Director of MDT, work in collaboration with the care and education teams, supporting and providing guidance where appropriate:

As a child and adolescent psychotherapist, you'll need to:

- ✓ Carefully observe children and young people and respond to what they might be communicating through their behaviour and play, logging these interactions in AWW assessment and Outcomes frameworks. But more importantly supporting our care teams to understand these presentations, in an attempt to better inform our service delivery
- ✓ Work with our care teams to assist them with responding and holding containment for children

- ✓ Provide assessment and support to children and adolescents as individuals or in a group. Through standardised psychometrics and internal AWW assessment methodology
- ✓ Tailor your approach to the individual child and work in an age-appropriate way. You might use play or drawing techniques with children who present as younger children, but talk about feelings with older teenagers
- ✓ Provide short-term and long-term interventions with children, young people and/or parents, from a few sessions to regular appointments over several years. As identified in individual therapeutic assessment plans and placement agreements
- ✓ Work alongside other professionals in planning how best to help a child and the child's family, for example in schools, hospitals, children's services and child protection agencies
- ✓ Work as part of AWW's multidisciplinary team made up of consultant psychologists, social workers, special educational needs coordinators (SENCOs), family therapists and departmental administrator's
- ✓ Offer training, consultation and supervision to our care and education teams who work with our children.

 At time work with families in the community to help and support a transition back into a family home, or ultimately support a permanency plan
- ✓ At times supervise other members of the AWW MDT including potential trainee child psychotherapists and other therapists, or social workers who are going through their registration with HCPC
- ✓ Plan service delivery in conjunction with our service managers and education leads
- ✓ Be instrumental in communicating your work through our standard assessment placement 'discharge summaries' to support the concept of permeance post children leaving our service
- ✓ Keep up to date with developments in theory and research and undertake continuing professional development (CPD)
